### GS/OAS and Panama sign agreement to support more than 800 refugees and refugee claimants in the Darien region

On October 4, 2023, an agreement was signed in Panama City between the General Secretariat of the Organization of American States (OAS), the Ministry of Government of the Republic of Panama and the City of Knowledge Foundation, for the implementation of the project that sets the starting point of the project "Strengthening the care, integration and protection of refugees, asylum seekers and host communities in the Darien province".

This project will benefit more than 800 refugees and asylum seekers through:

- ✓ The delivery of basic humanitarian assistance kits for health and hygiene (taking into account the differentiated needs of women, men, girls and boys);
- ✓ The delivery of school kits for children and adolescents;
- ✓ Training in microenterprises and basic equipment to women entrepreneurs in the area.

## GS/OAS and Costa Rica agree to strengthen assistance and protection for more than 23,000 refugees and asylum-seekers

On November 10, 2023, Costa Rica joined the countries in the region that are implementing initiatives financed by the MIRPS Fund, by signing the agreement that sets the starting point for the implementation of the project called "Strengthening the Identification and Referral of Persons Applying for Refugee Status and/or with Profiles of Special Vulnerability through the Modernization of Costa Rica's Refugee Unit Platform."

With the implementation of this project, improvements will be made to the procedures of the Refugee Unit of the General Directorate of Migration and Foreigners, to provide more agile attention to persons requesting refugee status and deserving international protection. Some 23,000 people will benefit directly, as well as approximately 10,000 other people applying for refugee status with some type of vulnerability, located throughout Costa Rica.
