

The Department of Social Inclusion (DSI), responsible for the administration and management of the MIRPS Fund, has made significant efforts to implement the Fund, in line with the support required by the MIRPS States and in addition to the existing mechanisms to respond to the challenges of forced displacement in Central America and Mexico.

In this regard, the DSI in coordination with the MIRPS States and strategic partners, has developed several activities during the third guarter of 2024.

60 families received seed capital as part of the project "Enhancing the Livelihoods of Returnee Children and Adolescents in need of Protection and their families".



As part of the project's activities, on September 16, CONAPINA delivered seed capital to the 60 beneficiary families of this initiative. The objective is to promote entrepreneurship that will generate durable solutions, thus promoting their social and economic integration in host / origin communities.

On September 17, the Human Rights Secretariat (SEDH by its acronym in Spanish) of the Republic of Honduras presented progress on the project "Strengthening Governmental Response to Assist Internally Displaced Persons in Honduras." During the presentation, it was highlighted that to date, over 80 individuals have benefited from the project's priority areas, which include:

- 1) Improving immediate response through the provision of humanitarian assistance and interinstitutional coordination to ensure the protection of over 25 families;
- 2) Creating durable solutions for 4 families by linking them to livelihoods through the provision of seed capital; and

3) Strengthening the capacities of the municipal governments of La Ceiba and Catacamas with the goal of consolidating assistance for internally displaced persons, in line with the provisions of the Law on the Prevention, Care, and Protection of Internally Displaced Persons.

The capital, delivered at an event held in the Ipetí community, will help strengthen the livelihoods of these women and their families.

Project: "Public Awareness Campaign and Border Presence"

The signing event for the agreement between the OAS General Secretariat and the Ministry of Immigration of Belize is scheduled for the next quarter, marking the launch of another initiative added to the First Project Portfolio.



COSTA RICA

Project: "Strengthening the Identification and Referral of Persons Applying for Refugee Status and/or with Profiles of Special Vulnerability through the Modernization of Costa Rica's Refugee Unit Platform".

Improvements to the Refuge Unit will be completed by the end of December. These upgrades will take into account the specific characteristics of the population of interest, as well as accessibility and inclusion considerations, enabling the implementation of more efficient processes.

Project activities are scheduled to be completed in December, thus initiating the closing period.

The implementation of the project is 70% complete and the final stage of execution will begin, which is scheduled for completion in January 2025.

The second and final disbursement of seed capital for women entrepreneurs from the host communities will take place at the end of November. Additionally, the process of coaching and follow-up will continue.
