



COMPREHENSIVE REGIONAL PROTECTION AND SOLUTIONS FRAMEWORK FUND (MIRPS FUND)

The OAS Department of Access to Rights (DAR) continues to strengthen the implementation of the MIRPS Fund in coordination with States and strategic partners, within the framework of the National Action Plans. During the fourth quarter of 2025, various activities were carried out aimed at strengthening the regional response to displacement.



RESULTS PRESENTED FOR AN INITIATIVE THAT PROMOTES PROTECTION, REINTEGRATION, AND LIVELIHOODS FOR RETURNED FAMILIES IN EL SALVADOR

On November 19, 2025, was held the presentation of results of the project “Enhancing the Livelihoods of Returnee Children and Adolescents in Need of Protection and Their Families in El Salvador”. The initiative was implemented by the National Council for Early Childhood, Childhood, and Adolescence (CONAPINA by its acronym in Spanish).

The project exceeded its original target by benefiting 70 returned families—equivalent to more than 300 people—surpassing the initial goal of 60 families. Key results include:



- **180 humanitarian assistance deliveries**, including supermarket cards to meet basic needs.
- **60 seed capital grants** awarded to promote family-based enterprises.
- **60 technical and specialized training scholarships**, complemented by a comprehensive intervention model combining assistance, capacity building, financial and nutritional education, and territorial accompaniment.



The initiative was funded with USD 100,000 from the MIRPS Fund and an additional contribution of USD 46,800 from CONAPINA.

The presentation included the participation of representatives from DAR/OAS and CONAPINA, who highlighted the impact of cooperation in providing training opportunities, livelihoods, and greater stability for beneficiary families, as well as the importance of comprehensive approaches to addressing the challenges of human mobility.

RESULTS PRESENTED FOR AN INITIATIVE THAT STRENGTHENS THE HONDURAN STATE'S RESPONSE TO INTERNAL DISPLACEMENT CAUSED BY VIOLENCE

On December 17, 2025, the presentation of results of the project “**Strengthening the governmental response to assist internally displaced persons due to violence**” was held.

The event brought together representatives of public institutions and international organizations, including Honduran authorities and the OAS General Secretariat through its Department of Access to Rights (DAR), and highlighted the key achievements in assisting internally displaced persons affected by violence. Key results include:



- **113 people received immediate humanitarian assistance**, including temporary shelter, food, hygiene kits, transportation, psychosocial care, and legal counseling.
- **22 people benefited from seed capital for family initiatives**, with an emphasis on women entrepreneurs.
- **27 public officials strengthened institutional capacities in La Ceiba and Catacamas**, supporting the future establishment of Municipal Units for the Care and Protection of Forcibly Displaced Persons (UMAPPDEF).
- Progress was made in consolidating the National System for the Response to Internal Forced Displacement and in strengthening coordination among state institutions, local governments, civil society, and international organizations.



The project was funded with USD 100,000 from the MIRPS Fund and an additional in-kind contribution of approximately USD 210,000 from the Secretariat of Human Rights of Honduras.

During the event, testimonies from beneficiaries were also presented, and the role of international cooperation in promoting comprehensive responses to internal displacement was highlighted.
